Theresa Bush, 845 Wells Fargo, Jacksonville, Or. 97530 also had questions about the presentation and had staff show her exactly where the envelope was potentially going to expand to and wanted to make sure it would meet solar code requirements. Staff said the house would only be a single level home. She also wanted to make sure this hearing was about the building envelope only, and not the structure itself.

Business from Commission and staff:

a) Planning Director Report: We have been working through our Comprehensive Plan amendments to Chapter One with the CAC and it's moving along surprisingly efficiently. We've

been following out current comp plan and having monthly townhalls regardless if we have much to report on, so this language needs to be fixed to possibly state townhalls "as needed". The last townhall we had 2 members of the public attend. So, updating Chapter One has been the bulk of our work here in the Planning Department. It will be coming before the Planning Commission soon, we're hoping to wrap it by March, and then we'll be headed to study sessions. Zac is settling in with us and doing a really good job, we're happy to have him on board. Vice Chair Thom would like to see cleaner maps in our staff reports, Zac reminded him that we use what the applicants provides us, but next time we will make it more clear and easier to understand.

- b) **HARC Liaison Update:** The HARC approved the design of a house that will be built at 900 South Oregon Street. We also looked at the design for the ADA access to the Courthouse. Also, the Nunan Mansion proposal will be continued again to the HARC March hearing.
- City Council Liaison Update: Steve Casaleggio introduced himself to Commissioners, he has served our Council since 2016 he has been very active in the Boosters and served as the President for a couple of years. He has experience with our transient tax committee, was Chair of Parks, and most recently is liaison for our Cemetery commission. When Donna Bowen was put on City Council, and Brad Bennington moved off, Steve was kicked upstairs. City council is looking at a couple of options for the Courthouse elevator, one is an interior and the other is exterior, right now we're struggling with cost. Right now, there is a proposal to create a single-story enclosed self-operating elevator to go from the ground to the first floor. Last night the Council approved a project that will be funded by the Boosters club which will be series of 18x48 granite panels to be inserted in the sidewalk in front of City Hall/Old Courthouse which will have text describing events of the history of Jacksonville, starting at 1850 close to present day.
